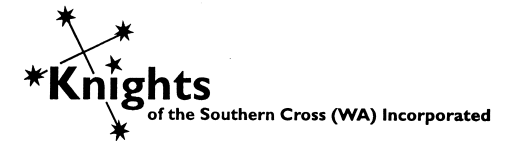

### NOTE 1: STATEMENT OF ACCOUNTING POLICIES

The financial statements are a special purpose financial report that have been prepared in accordance with Australian Accounting Standards and other mandatory professional reporting requirements and the requirements of the Association Incorporations Act (WA). The financial statements have also been prepared on the basis of historical costs and do not take into account changing money values or, except where stated, current valuations of non-current assets. Cost is based on the fair values of the consideration given in exchange for assets. The accounting policies have been consistently applied, unless otherwise stated.

The following is a summary of the material accounting policies adopted by the Association in the preparation of the financial statements.

(a) Income Tax

As a non profit body the association is not subject to income tax as accepted by The Australian Tax Office

### NOTE 2: INCORPORATION

The Association was established on 5th of June 1997 upon a resolution of Committee members passed at a meeting held 12th of October 1996.

### NOTE 3: SEGMENT INFORMATION

The Association's objects are broadly to relieve poverty and suffering in Vietnam through a charitable Trust Fund for the provision of bursaries for the education of Vietnamese Children.

I report on the activities and operations of the Overseas Aid Fund for the Education of Children in Vietnam (OFEC) over this twelfth year of operation. Firstly, I wish to acknowledge the Order of Knights of the Southern Cross in Western Australia who has generously supported OFEC from the outset.

In the year under review the committee approved six education awards and altogether \$7000.00 AUD was forwarded to Vietnam - an increase over 400%. As is standing policy the Awards are subject to satisfactory progress.

In each case our committee received a documented Application for Scholarship. All Applications were thus approved after full examination.

I have previously stated that OFEC would like to do much more and, in future we hope to achieve much more. This possibility is evident through your support. Donations happily increased by almost 95% - so let this be a mark of future growth for OFEC.

Expenses were quite minor. Aside from \$80.00 Legal and Bank costs the only other expense was \$1000.00 being the Realisation of a Loan.

Fortunately, OFEC Founder Rev Fr Peter Hung Manh Tran is still here in Western Australia. His ready support and counsel has been a feature of his presence. All this in addition to the work at the LJ Goody Bioethics Centre.

We remain ever grateful for the support given to OFEC by volunteers in Vietnam. There they carry out a dynamic role in overseeing disbursement of scholarship funds.

Since Balance date there has been some additions to the committee. To these members – a warm welcome is extended. I am sure OFEC will benefit by their presence.

I have elected to stand down as Chairman at the next Annual Meeting. It would be quite unfair if I did not say *"thank you, all"* for the unstinting help that I have been so proud to witness since the beginning of OFEC. I hope and pray that OFEC will be very successful in achieving its meritorious goal.
